THE EQUIPMENT IS PROVIDED "AS IS," AS A CONVENIENCE TO ME, WITHOUT ANY EXPRESS OR IMPLIED WARRANTIES OR LIABILITIES ON THE PART OF HARD ROCK HOTEL, HARD ROCK INTERNATIONAL, INC., FENDER, OR ANY OF THEIR RESPECTIVE OWNERS, OFFICERS, EMPLOYEES, AGENTS OR AFFILIATES (collectively, "the Released Parties"). To the greatest extent permitted under applicable law, I release and waive any and all claims of liability, damages and injuries against the Released Parties in relation to the Equipment and my use/possession of it. I further agree to indemnify and hold harmless each and all of the Released Parties against any and all claims (whether meritorious or not), loss, injury or damage arising from or related to the Equipment or its use, except where such claims arise directly from the gross negligence or willful misconduct of the Released Parties. I acknowledge that there is a possibility that, subsequent to the execution of this Agreement, I may discover facts or incur or suffer claims which were unknown or unsuspected at the time this Agreement was executed, and which if known by me at that time may have materially affected my decision to execute this Agreement and the releases herein. I am assuming any risk of such unknown facts and such unknown and unsuspected claims. I have been advised of the existence of Section 1542 of the California Civil Code, which provides: A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR. Notwithstanding such provisions, this Agreement and the releases herein shall constitute a full release in accordance with its terms. I voluntarily waive the provisions of Section 1542, as well as any other statute, law or rule of similar effect, and acknowledges and agrees that this waiver is an essential and material term of this Agreement. I have been advised and agree that it may seek legal counsel prior to signing this Agreement.
- 5. GOVERNING LAW. Any claim or dispute arising from or related to this Agreement shall be governed by the laws of the State of Arizona or jurisdiction in which this Agreement was entered into shall govern, without reference to conflict of laws. The sole and exclusive venue for such disputes shall be the federal, state or other judiciary located in that jurisdiction, with the initial claim being asserted in the court or forum closest to the Hard Rock Hotel's location. I waive any right to trial by jury and agree that any disputes should be resolved without a jury.

I agree that this English-language Agreement constitutes the full and entire agreement with regard to its subjects and that I: (a) am not relying on any other documents or any communications or representations not expressly set forth in the text of this Agreement; and (b) expressly waive the right, if any, to have this Agreement set forth in, governed by or interpreted by a language other than English.
