



Release and Waiver of Liability Assumption of Risk and Damage Compensation Agreement ("Agreement")

In considering participation in The Earth Hour Run 2023, I hereby certify that I understand the nature of this activity. I am qualified with good health and am physically fit to participate in these activities. I acknowledge that if the activities that such organizers have planned will create unsafe conditions for myself, I will immediately stop participating in these activities.

I understand very well that this activity carries a risk of serious injury, including permanent disability, paralysis, and death, which may have been caused by my own actions. The inaction of others participating in the activity under which an event will occur, or the negligence of the "publication" described below. And may have other risks that I do not know or cannot foresee at this time. I accept and bear all such risks and am responsible for all losses, expenses, and damages arising from participating in these activities.

I let go of Release and make a commitment not to sue Hard Rock Hotel Pattaya, its management, directors, representatives, volunteers, other employees, participants, sponsors, advertisers, and, where applicable, the owners, for the lesser extent to which these activities are carried out. Each transaction is treated as a "release" from all of my liabilities, claims, demands, losses, or damages arising or allegedly caused by the negligence of all or part of the "publishing," in whole or in part, or otherwise, including the negligent operation of the assistance. And I continue to admit that, despite this release liability waiver and assuming the risk, I or anyone acting on my behalf would claim any release. I will indemnify, save, and hold harmless each release from any loss of liability or any expenses that may arise as a result of such claims.

I have read the release and waiver of liability, assumption of risk, and damage compensation agreement. Then I understand that I have waived essential rights by signing and have signed freely without inducement or endorsement of any kind. This is intended to be a complete and unconditional release of all liability to the fullest extent permitted by law.

The requirements that applicants must accept and comply with are as follows:

1. The organizer is not responsible for any damage caused by
 - Illness or accident (staff will respond to the initial emergency)
 - Loss or damage to personal property
 - Delays in matches caused by factors beyond our control
2. Participants must arrive at the venue at least one hour before the event begins. The starting point gates will be closed 15 minutes prior to the start time for each stage of the race.
3. Participants must follow the instructions of the organizer and the course judges; otherwise, they may be disqualified from participating in the competition.
4. It is the participant's responsibility to review the announcements from the organizer before and during the competition.
5. The organizer manages the personal data of applicants with privacy and security as the top priorities.
6. Because we are organizing this event for charity and to help society, it is not a standard record race.
7. This event will not be able to close all roads. Therefore, the participants are requested to exercise caution and strictly follow the instructions from the field staff.
8. Participants allow the organizers to use pictures from the event for publicity in various media.
